

FROM THE DIRECTOR

The year 2018 was an active and eventful year at HEUNI. In January I formally started working as the director. It was with great pleasure that I took on this new role. HEUNI may be a small organisation, but our staff is knowledgeable, innovative and hard-working; qualities that make HEUNI excel. Both the organisation and I have changed and grown over the course of this year; we have taken on board new routines and tools e.g. concerning time and project management, and we also welcomed Elina, our new colleague.

Year 2018 was also the year of partnerships. During the year, we worked to forge connections with policy-makers, researchers, non-governmental organisations and businesses. We launched two major studies that assessed assistance provided to victims of human trafficking, and we launched concrete guidelines for companies on how to prevent exploitation in local subcontracting chains.





We continued to work to prevent radicalisation in prison and continued data collection on migrant women's experiences of gender-based violence. We also received funding for a new project to prevent and investigate financial crimes in conjunction with labour exploitation. An additional major undertaking this year has been our collaboration with UNODC in conducting a global study on the linkages between human trafficking and marriage. This report will be launched by UNODC in 2019.

This past year we also focused on increasing HEUNI's visibility. We've published ten newsletters, revamped the visual look of our power point presentations and created two online training courses (available here: heuni.education). We increased our presence in social media and used it as a way to disseminate the results of our work. Furthering our communication skills and products is something we will emphasise also in the years to come.

OPERATIONAL FRAMEWORK

The European Institute for Crime Prevention and Control, affiliated with the United Nations (HEUNI) is the regional European link in the United Nations Crime Prevention and Criminal Justice Programme Network. HEUNI was established through an Agreement between the United Nations and the Government of Finland signed on 23 December 1981 and extended on 14 April 1987.

The primary objective of HEUNI, as outlined in the Agreement, is to promote the international exchange of information on crime prevention and control among European countries. The frame of reference is given by the United Nations Crime Prevention and Criminal Justice Programme, as determined by the United Nations Commission on Crime Prevention and Criminal Justice, although mandates are also received directly from the countries served by HEUNI.

UPDATED STRATEGY

• During 2019, HEUNI will develop its next five-year strategy, covering the years 2020-2025. The strategy will elaborate on HEUNI's values and mission, as well as provide concrete, strategic goals for the coming five years. The strategy process includes a stakeholder survey so as to capture how HEUNI is perceived by external partners and how they see HEUNI's role. The process also includes the use of the Common Assessment Framework (CAF) as a self-assessment tool in order to develop an improvement plan. The strategy process is also looking into how to strengthen the measurement of impact. The strategy will be finalized during the second half of 2019, and will be launched at the end of the year.

HEUNI'S ORGANISATION

The administrative responsibility for HEUNI lies with the Government of Finland. All members of the staff are Finnish government officials. In accordance with article 2 of the Agreement, HEUNI operates under the joint auspices of the United Nations and the Government of Finland. 

CONCLUDED PROJECTS

EFFECTIVENESS OF THE FINNISH LEGISLATION ON IDENTIFYING AND SUPPORTING VICTIMS OF TRAFFICKING IN PERSONS

The so-called Reception Act (746/2011) of Finland contains provisions on the identification of and support for victims of trafficking. The Parliament of Finland has called for a review of the implementation of the Act to ascertain its efficiency and effectiveness from the point of view of the recovery of the victims of trafficking in persons. The Prime Minister's Office commissioned the Non-Discrimination Ombudsman and HEUNI to jointly carry out a study on how the provisions on identification and support are applied, and what problems there are in the application of the current law. The report was launched in March 2018 at a seminar in Helsinki.

The research has two key findings: first, that the social and health administration in municipalities is not familiar with the law that applies to the assistance to victims of human trafficking and as a consequence, victims of trafficking do not always receive the statutory services they are entitled to. There are also significant differences between municipalities in the awareness of the obligations towards victims of trafficking, leading to unequal treatment of victims depending on which municipality they happen to reside in. Second, the research shows that there is a strong link between the provision of assistance to victims of trafficking and the criminal justice process, and as a consequence, a significant share of victims of trafficking do not seek help from the authorities. The fact that assistance to victims of trafficking is tied to the criminal process and its outcome both prevents victims of human trafficking from seeking assistance from the authorities and removes them from the remit of assistance if and when the criminal justice process is terminated.

The research consequently suggests that there is a need to enact a special act on assistance for victims of human trafficking, where the link between assistance and the criminal justice process is alleviated. Should a separate new act not be feasible, the relevant authorities should issue clear instructions to municipalities on how to apply the current law.

The study was incorporated into the report of the Non-Discrimination Ombudsman to the Parliament, and HEUNI was called to two Parliamentary hearings to present its view on the need for legislative changes. In order to roll out the findings of the research and the recommendations further, HEUNI staff members have presented the results of the study at several events. These include lectures for social and health care workers, counsellors, researchers, and practitioners.

NORDIC PROJECT ON CORPORATE SOCIAL RESPONSIBILITY AND LABOUR EXPLOITATION

In cooperation with the Ministry of Health and Social Affairs (STM), HEUNI published new guidelines for companies on how to manage the risk of hidden labour exploitation and trafficking in local subcontracting chains. The project was part of a wider Nordic project funded by the Nordic Council of Ministries and led by the Danish Center against Human Trafficking (CMM) where Danish guidelines for businesses were tailored and amended to suit the contexts of the other Nordic countries. HEUNI was responsible for the national implementation of the project in Finland, which was financially supported by the Ministry of Social Affairs and Health. HEUNI cooperated closely with representatives of many businesses in tailoring the guidelines to suit the Finnish context. The guidelines include examples of exploitation in supply chains, and detailed checklists for businesses on how to address and prevent exploitation through contractual and other means.

The launch of the guidelines brought together national experts from both the private and the public sectors. The guidelines were welcomed as an important addition in the field of corporate social responsibility. They offer concrete tools to manage national subcontracting chains from a human rights perspective, and supplement existing CSR norms and regulations. HEUNI has continues the dialogue with the private and public sector on this topic, and HEUNI experts attended several training events and talked about the guidelines to businesses, employers, organisations, practitioners, and trade unions.

GLOBAL RESEARCH ON MARRIAGE TRAFFICKING

The purpose of the assignment was to assist UNODC in the development of a technical paper on the links between marriage and trafficking in human beings. HEUNI implemented a global research component, exploring the extent to which different forms of marriage trafficking fall under the UN Trafficking in Persons Protocol (or the Smuggling of Migrants Protocol) or something else entirely. The research component looked at the various modus operandi used for different forms of marriage trafficking, including the involvement of organized criminal groups, as well as the profile of the victims and the offenders. The research covered fieldwork in 9 countries. The research found several different links between marriage and trafficking. The paper also concludes that there is a lack of awareness of marriagerelated trafficking among authorities and service providers, the current legal frameworks and definitions are insufficient to cover the phenomenon, leading to insufficient protection of victims. TRAFFICKING ALONG MIGRATION ROUTES (TRAM)

TRAM-project "Trafficking along Migration Routes (TRAM): Identification and Integration of Victims of Trafficking among Vulnerable Groups and Unaccompanied Children", focused on supporting and enabling the early identification, referral, protection and rehabilitation of trafficked people along migration routes. The project resulted in the report "Trafficking along Migration Routes to Europe Bridging the Gap between Migration, Asylum and Anti-Trafficking" covering Austria, Germany, Finland, Sweden, Greece, Bulgaria, the former Yugoslav Republic of Macedonia and Serbia, examining the incidence of trafficking in human beings (THB) and risk factors for THB in the context of the Balkan route and in the destination countries. It also looked at the gaps, needs and challenges that exist in the identification, referral, protection and rehabilitation of victims of trafficking. HEUNI's senior programme officer Anniina Jokinen was part of the research team and completed the country research for Finland and Sweden. Commissioned by the CBSS, HEUNI implemented the project activities on integration of trafficking victims in Finland also developed a road map and a poster on the topic which was published by CBSS as part of the "Road map for integration of victims of trafficking among migrants in Finland, Germany and Sweden".

FLOW: FLOWS OF ILLICIT FUNDS AND VICTIMS OF HUMAN TRAFFICKING: UNCOVERING THE COMPLEXITIES

The FLOW project promotes a holistic approach to the prevention and investigation of trafficking in human beings (THB) in conjunction with economic crime and engages businesses in the prevention of THB.

THB is an end result of complex interconnections between unsustainable business practices, organized crime, corruption and illicit flows. It is crucial to understand these connections, and to ensure cooperation between business, law enforcement and labour inspectors to tackle this nexus. The project addresses this gap by creating investigation guidelines for law enforcement, with the aim to promote a more holistic approach to the investigation of THB, in particular in conjunction with economic crime and illicit financial flows. Secondly, this project acknowledges that THB is driven by the possibility to make profit on many levels, and businesses profiting from THB are not restricted to criminal organisations. In fact, it is often a chain of legitimate businesses that engage in THB, both knowingly and unknowingly and this is addressed through CSR tools and guidelines. The project will therefore develop a risk-management tool for businesses so as to prevent labour exploitation and financial crimes.

BOUNDARIES OF EXPLOITATION? - HUMAN TRAFFICKING, ITS VICTIMS AND PERPETRATORS IN 21ST CENTURY FINLAND

Minna Viuhko's dissertation deals with human trafficking and related exploitation. The study analyses transnational human trafficking and exploitation processes, the role of organised crime in trafficking activities, the agency of the victims and control imposed on the victims by the perpetrators, as well as the relationships and power relations between the victims and the offenders. Ms Viuhko's doctoral studies are carried out at the University of Helsinki. 
